PERMIT FEES

(BUILDING, PLUMBING, MECHANICAL, ELECTRICAL, FIRE PREVENTION, DEMOLITION, & SIGN PERMITS)

This is only an overview of fees associated with the issuance of permits and is not intended to be inclusive.

- → All **permit fees** are calculated based on the value of the work being performed. Use Valuation Table B for electrical permits and Valuation Table A for all other permits (see next page).
- ➤ Valuation for remodels, tenant improvements, alterations, etc. shall be provided by the applicant based on a legitimate bid or cost estimate that reflects the fair market value of all elements of the project (labor and materials).
- → A copy of a contractor's bid or estimate may be required for verification of the valuation provided. The Building Official has the authority to assign a project valuation when the cost information provided is not consistent with industry standards.
- Residential project **valuation for new construction** or additional square footage is based on a set cost per square foot as determined by the Building Official.
- ▶ Plan review fees, when required, are in addition to permit fees, based on 65 percent of the calculated permit fee.
- ➤ Commercial building permits will be charged a **Fire Department** review and inspection fee based on 15 percent of the calculated permit fee, with a minimum charge of \$89.39.
- → All **building** permits include a WA State Building Code Council (SBCC) Surcharge; \$6.50 for residential permits and \$25 for commercial permits. This fee does not apply to other types of permits.
- → An **automation fee** will be included on all permits. The fee is the greater of \$41 or five percent of the permit fee.
- ➤ In addition to permit and plan review fees, **sign permits** are also subject to the following:
 - *Planning Surcharge*: \$66 for 1st sign; \$24 for each additional sign on the same application.
 - *Electrical Fees:* \$88 for 1st sign; \$41 for each additional sign on the same application.
