

NOTICE OF LAND USE APPLICATION

Project Name: Creekwood Preliminary Plat

Project Description: Proposed subdivision of one 19.86-acre parcel into 20 single-family residential lots with a new public road and tracts for drainage, environmental critical areas, and open space. Road access is proposed from the northeast via 21st Ave SW and from the north via 22nd Ave SW. The site is zoned RS 15.0 which requires a minimum lot area of 15,000 sq. ft. The applicant proposes a cluster subdivision to allow minimum lot areas below the RS 15.0 requirement when Federal Way Revised Code (FWRC) 18.55 design standards are met.

Requested & Related Decisions, & Other Determinations Included with Application: Preliminary Plat Application File # 22-105973-SU pursuant to FWRC 18.35 and 18.55.040; *State Environmental Policy Act* Threshold Determination File # 22-105974-SE; Transportation Concurrency File #s 22-105975-CN and 22-103594-CN; Class IV Forest Practices file #23-100093-AD; Street Modification Request #22-105976-SM; and requests to use cast-in-place reinforced concrete retaining wall for public road crossing (file #22-105978-AD) and cast-in-place reinforced concrete storm water vault (file #22-105977-AD). This is an updated preliminary plat from three past prelim plat applications for this parcel: 2019 and 2017 expired applications (file #s 19-103218-SU and 17-103947-SU), and 2014 withdrawn application (file #14-100957-SU). A SEPA Mitigated Determination of Non-Significance was issued 4/10/2015 for the 2014 application that was withdrawn (SEPA #201501682); A SEPA determination has not yet been made for the current application.


Development Regulations Used for Project Mitigation: FWRC Title 14, "Environmental Policy"; Title 16, "Surface Water Management"; Title 18, "Subdivisions"; and Title 19, "Zoning and Development Code."

Consistency with Applicable Plans and Regulations: The project will be reviewed for consistency with all applicable policies and regulations, including but not limited to: The Federal Way Comprehensive Plan; King County Surface Water Design Manual; Public Works Development Standards; Lakehaven Water and Sewer System Design and Construction Standards; South King Fire and Rescue Administrative Policies; Federal Way Public Schools Safe Access Policies; and FWRC Titles 14, 16, 18, and 19.

Public Comment: Any person may submit written comments on the application to the Hearing Examiner (the decision-maker) and shall deliver these comments to the Community Development Dept. prior to the public hearing date, or directly to the Hearing Examiner at the hearing. Any person may provide verbal comments during the public hearing. A Notice of Public Hearing will be issued approximately 15 days prior to the hearing date.
