Notice is hereby given that the City of Federal Way Hearing Examiner will hold a virtual/telephonic public hearing on March 7, at 2:00 p.m. by means of Zoom to consider the following proposal:

Project Description: Applicant proposes establish Planting Flowers Learning Center classified as a day care use per FWRC 19.205.120. A process IV land use permit is required for day care in the Multi-family zone for 12 to 50 attendees. The site contains an existing commercial office building. An outdoor play area will be established on site as required by code. The site is zoned RM 1800.
